Company's healthy Status & Growth Potential

Before 1935, Heera Trading Co. carried on the trade in Japan as a founder. This company has 70 years history.

Company established in 1990 by current President Sakhrani Atoo Heera and the current capital is ¥ 40,000,000 . Since the establishment this company is operating smoothly without any debt. This company opens it first Natural and Organic Foods Retail Store from 1st April 2009 (Zest Food). The plan is to develop a chain of stores.

Due to the enhancement related to recent conditions and BSE(mad cow) problems, our company has developed strong relation with the customers regarding the safety of food. Recently, organic markets in Japan are expanding vigorously i.e. approximately 20% every year. This is the 3rd largest volume in the world. (1st America, 2nd EU and 3rd Japan).

Customers cannot normally find the goods such as Natural and Organic sufficiently even in retail stores and big supermarkets etc., due to this customers needs are not satisfied. The shop specialized with Natural and Organic Goods like our shop gives importance to the safety of food, and due to this , the customer gets satisfied. It is possible to expect great growth potential as a developed type of business.

In retail shop approximately 100 million yen sale is forecasted in the first year. When wholesale business is carried out approximately 200 million yen sale is forecasted in 2009.
